CALL TO ORDER

A Board meeting of Olde Town Covington was held on Monday, June 24,2024 at the Olde Town Covington Office, at 12:02 PM, presided over by Lisa Akers, Interim President with Secretary, Wanda Crawford taking notes.

APPROVAL OF MINUTES

A quorum was present. A motion to approve the April 2024 board meeting minutes was made by Terri McClung, seconded by Lisa Sponaugle.

COMMITTEE REPORTS

Treasurer's Report - Jaime Hale was not present, however, she did reported the account balances for Olde Town Covington \$28,299.64 and Special Events Account \$9,526,51

Adopt-A-Highway - no update at this time

Executive Committee - Lisa Akers, Interim President noted that Thomas Smals has resigned and Jennifer Smith will remain on the board but no longer wishes to hold the President's position. Lisa Akers stated she does not wish to be the President but is willing to stay until the position is filled. Executive Director position is complete and has been posted, Applications will be received from July 1 thru July 31st. With a pay scale of 35 to 40K, The City has approved \$65,000.00 to Olde Town Covington. Event Committee will be headed up by Jennifer Smith, next event is Christmas in July on July 12th. Cinco de Mayo will be our main event each year. Jennifer was a lot of help with Mid City Music Fest, however the event was not promoted and advertised as it should have been resulting in poor attendance. We lost a little over 10K even with the city jumping in and paying Tidy for Porta Johns and for the promo banners.

Volunteer Committee - Jennifer reported we still need someone to head up this committee and volunteers for Christmas in July.
